Weekly Update of Claims Activity

Week Ending: September 8, 2018

Unemployment Insurance

Initial Claims – 622 initial claims were processed during the week ending 9/8/18, a decrease of 65 from the previous week, and a decrease of 80 from a year ago. The number of initial claims filed to date is down 3.9 percent from last year and down 12.8 percent from two years ago.

Continued Claims – 6,930 continued claims were processed during the week of 9/8/18, a decrease of 1,572 from the previous week and a decrease of 348 from a year ago. The number of continued claims filed to date is down 6.3 percent from last year and down 7.7 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 13 initial claims and 277 continued claims were processed. An estimated 4 layoffs were averted this week, as a result of Workshare.

Exhaustions – 136 individuals exhausted their regular payments this week an increase of 29 from the previous week and a decrease of 25 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 756 initial claims and 6,362 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$506 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 33,358.

Temporary Caregiver Insurance – Of the 756 TDI initial claims, 251 (33.2%) were TCI Claims. This week 388 TCI payments were issued totaling \$219,479. The average weekly TCI payment was \$566. Of the 33,358 TDI claims filed in 2018, 8,432 or 25.3% were TCI claims.
