Weekly Update of Claims Activity

Week Ending: September 1, 2018

Unemployment Insurance

Initial Claims – 687 initial claims were processed during the week ending 9/1/18, a decrease of 71 from the previous week, and a decrease of 62 from a year ago. The number of initial claims filed to date is down 3.8 percent from last year and down 12.9 percent from two years ago.

Continued Claims – 8,502 continued claims were processed during the week of 9/1/18, a decrease of 314 from the previous week and a decrease of 323 from a year ago. The number of continued claims filed to date is down 6.3 percent from last year and down 7.7 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 15 initial claims and 308 continued claims were processed. An estimated 3 layoffs were averted this week, as a result of Workshare.

Exhaustions – 107 individuals exhausted their regular payments this week a decrease of 24 from the previous week and a decrease of 18 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 696 initial claims and 6,917 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$515 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 32,602.

Temporary Caregiver Insurance – Of the 696 TDI initial claims, 252 (36.2%) were TCI Claims. This week 493 TCI payments were issued totaling \$279,768. The average weekly TCI payment was \$567. Of the 32,602 TDI claims filed in 2018, 8,181 or 25.1% were TCI claims.
