## Weekly Update of Claims Activity

Week Ending: July 21, 2018

## **Unemployment Insurance**

**Initial Claims** – 656 initial claims were processed during the week ending 7/21/18, a decrease of 438 from the previous week, and a decrease of 167 from a year ago. The number of initial claims filed to date is down 5.6 percent from last year and down 14.5 percent from two years ago.

**Continued Claims** – 9,123 continued claims were processed during the week of 7/21/18, a decrease of 333 from the previous week and a decrease of 492 from a year ago. The number of continued claims filed to date is down 6.8 percent from last year and down 7.8 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 17 initial claims and 305 continued claims were processed. An estimated 5 layoffs were prevented this week, as a result of Workshare.

**Exhaustions** – 143 individuals exhausted their regular payments this week a decrease of 11 from the previous week and a decrease of 23 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 1,293 initial claims and 7,090 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$505 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 27,016

**Temporary Caregiver Insurance** – Of the 1,293 TDI initial claims, 227 (17.6%) were TCI Claims. This week 457 TCI payments were issued totaling \$238,915. The average weekly TCI payment was \$523. Of the 27,016 TDI claims filed in 2018, 6,620 or 24.5% were TCI claims.
