Weekly Update of Claims Activity

Week Ending: July 14, 2018

Unemployment Insurance

- **Initial Claims** 1,094 initial claims were processed during the week ending 7/14/18, a decrease of 119 from the previous week, and an increase of 135 from a year ago. The number of initial claims filed to date is down 5.2 percent from last year and down 14.4 percent from two years ago.
- **Continued Claims** 9,456 continued claims were processed during the week of 7/14/18, an increase of 940 from the previous week and a decrease of 535 from a year ago. The number of continued claims filed to date is down 6.9 percent from last year and down 7.8 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 32 initial claims and 327 continued claims were processed. An estimated 10 layoffs were prevented this week, as a result of Workshare.
- **Exhaustions** 154 individuals exhausted their regular payments this week an increase of 16 from the previous week and a decrease of 33 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 837 initial claims and 6,727 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$501 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 25,723

Temporary Caregiver Insurance – Of the 837 TDI initial claims, 234 (28.0%) were TCI Claims. This week 423 TCI payments were issued totaling \$229,385. The average weekly TCI payment was \$542. Of the 25,723 TDI claims filed in 2018, 6,393 or 24.9% were TCI claims.
