Weekly Update of Claims Activity

Week Ending: July 7, 2018

Unemployment Insurance

Initial Claims – 1,213 initial claims were processed during the week ending 7/7/18, a decrease of 658 from the previous week, and a decrease of 150 from a year ago. The number of initial claims filed to date is down 5.8 percent from last year and down 14.8 percent from two years ago.

Continued Claims – 8,516 continued claims were processed during the week of 7/7/18, an increase of 1,458 from the previous week and a decrease of 675 from a year ago. The number of continued claims filed to date is down 6.9 percent from last year and down 7.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 22 initial claims and 357 continued claims were processed. An estimated 7 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 138 individuals exhausted their regular payments this week an increase of 21 from the previous week and an increase of 7 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 657 initial claims and 6,196 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$510 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 24,886

Temporary Caregiver Insurance – Of the 657 TDI initial claims, 228 (34.7%) were TCI Claims. This week 424 TCI payments were issued totaling \$240,178. The average weekly TCI payment was \$566. Of the 24,886 TDI claims filed in 2018, 6,159 or 24.7% were TCI claims.
