Weekly Update of Claims Activity

Week Ending: May 19, 2018

Unemployment Insurance

Initial Claims – 827 initial claims were processed during the week ending 5/19/18, an increase of 109 from the previous week, and a decrease of 2 from a year ago. The number of initial claims filed to date is down 4.0 percent from last year and down 16.2 percent from two years ago.

Continued Claims – 6,547 continued claims were processed during the week of 5/19/18, a decrease of 183 from the previous week and a decrease of 840 from a year ago. The number of continued claims filed to date is down 6.1 percent from last year and down 6.3 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 19 initial claims and 513 continued claims were processed. An estimated 8 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 149 individuals exhausted their regular payments this week an increase of 16 from the previous week and a decrease of 21 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 821 initial claims and 7,156 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$496 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 18,334 TDI claims filed.

Temporary Caregiver Insurance – Of the 821 TDI initial claims, 255 (31.1%) were TCI Claims. This week 514 TCI payments were issued totaling \$291,718. The average weekly TCI payment was \$568. Of the 18,334 TDI claims filed in 2018, 4,561 or 24.9% were TCI claims.
