## Weekly Update of Claims Activity

Week Ending: March 31, 2018

## **Unemployment Insurance**

**Initial Claims** – 944 initial claims were processed during the week ending 3/31/18, an increase of 330 from the previous week, and an increase of 255 from a year ago. The number of initial claims filed to date is down 4.0 percent from last year and down 18.6 percent from two years ago.

**Continued Claims** – 10,593 continued claims were processed during the week of 3/31/18, a decrease of 449 from the previous week and a decrease of 1,063 from a year ago. The number of continued claims filed to date is down 5.0 percent from last year and down 4.7 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 18 initial claims and 231 continued claims were processed. An estimated 4 layoffs were prevented this week, as a result of Workshare.

**Exhaustions** – 169 individuals exhausted their regular payments this week an increase of 7 from the previous week and a decrease of 13 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 978 initial claims and 7,560 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$501 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 11,904 TDI claims filed.

**Temporary Caregiver Insurance** – Of the 978 TDI initial claims, 214 (21.9%) were TCI Claims. This week 460 TCI payments were issued totaling \$243,643. The average weekly TCI payment was \$530. Of the 11,904 TDI claims filed in 2018, 2,938 or 24.7% were TCI claims.
