## Weekly Update of Claims Activity

Week Ending: March 3, 2018

## **Unemployment Insurance**

**Initial Claims** – 842 initial claims were processed during the week ending 3/3/18, a decrease of 1,077 from the previous week, and a decrease of 10 from a year ago. The number of initial claims filed to date is down 3.2 percent from last year and down 20.9 percent from two years ago.

Continued Claims – 13,144 continued claims were processed during the week of 3/3/18, an increase of 1,104 from the previous week and a decrease of 915 from a year ago. The number of continued claims filed to date is down 3.4 percent from last year and down 4.0 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 9 initial claims and 314 continued claims were processed. An estimated 4 layoffs were prevented this week, as a result of Workshare.

**Exhaustions** – 141 individuals exhausted their regular payments this week an increase of 23 from the previous week and a decrease of 19 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 785 initial claims and 7,300 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$499 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 8,330 TDI claims filed.

**Temporary Caregiver Insurance** – Of the 785 TDI initial claims, 216 (27.5%) were TCI Claims. This week 453 TCI payments were issued totaling \$253,973. The average weekly TCI payment was \$561. Of the 8,330 TDI claims filed in 2018, 2,078 or 24.9% were TCI claims.
