Weekly Update of Claims Activity

Week Ending: February 24, 2018

Unemployment Insurance

Initial Claims – 1,919 initial claims were processed during the week ending 2/24/18, an increase of 928 from the previous week, and a decrease of 242 from a year ago. The number of initial claims filed to date is down 3.3 percent from last year and down 21.8 percent from two years ago.

Continued Claims - 12,040 continued claims were processed during the week of 2/24/18, a decrease of 216 from the previous week and a decrease of 886 from a year ago. The number of continued claims filed to date is down 3.0 percent from last year and down 4.7 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 20 initial claims and 396 continued claims were processed. An estimated 4 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 118 individuals exhausted their regular payments this week a decrease of 8 from the previous week and a decrease of 46 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 810 initial claims and 7,388 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$497 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 7,545 TDI claims filed.

Temporary Caregiver Insurance – Of the 810 TDI initial claims, 215 (26.5%) were TCI Claims. This week 410 TCI payments were issued totaling \$231,348. The average weekly TCI payment was \$564. Of the 7,545 TDI claims filed in 2018, 1,862 or 24.7% were TCI claims.
