Weekly Update of Claims Activity

Week Ending: February 10, 2018

Unemployment Insurance

Initial Claims – 889 initial claims were processed during the week ending 2/10/18, a decrease of 274 from the previous week, and a decrease of 41 from a year ago. The number of initial claims filed to date is up 0.5 percent from last year and down 24.0 percent from two years ago.

Continued Claims – 12,238 continued claims were processed during the week of 2/10/18, a decrease of 203 from the previous week and a decrease of 369 from a year ago. The number of continued claims filed to date is down 2.0 percent from last year and down 1.6 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 8 initial claims and 495 continued claims were processed. An estimated 3 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 138 individuals exhausted their regular payments this week an increase of 41 from the previous week and no change from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 958 initial claims and 7,135 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$508 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 5,816 TDI claims filed.

Temporary Caregiver Insurance – Of the 958 TDI initial claims, 255 (26.6%) were TCI Claims. This week 506 TCI payments were issued totaling \$292,719. The average weekly TCI payment was \$578. Of the 5,816 TDI claims filed in 2018, 1,417 or 24.4% were TCI claims.
