## Weekly Update of Claims Activity

Week Ending: February 3, 2018

## **Unemployment Insurance**

**Initial Claims** – 1,163 initial claims were processed during the week ending 2/3/18, a decrease of 147 from the previous week, and an increase of 69 from a year ago. The number of initial claims filed to date is up 1.1 percent from last year and down 22.6 percent from two years ago.

**Continued Claims** – 12,441 continued claims were processed during the week of 2/3/18, a decrease of 457 from the previous week and a decrease of 97 from a year ago. The number of continued claims filed to date is down 1.8 percent from last year and down 0.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 4 initial claims and 408 continued claims were processed.

**Exhaustions** – 97 individuals exhausted their regular payments this week a decrease of 22 from the previous week and a decrease of 51 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 973 initial claims and 6,943 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$492 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 4,858 TDI claims filed.

**Temporary Caregiver Insurance** – Of the 973 TDI initial claims, 195 (20.0%) were TCI Claims. This week 423 TCI payments were issued totaling \$230,686. The average weekly TCI payment was \$545. Of the 4,858 TDI claims filed in 2018, 1,162 or 23.9% were TCI claims.
